Notice of Application Pursuant to Section 511(1) of the Corporations Act 2001

This application is made under section 511(1) of the *Corporations Act 2001* (Cth) (**Act**).


This application is for directions to be given to a liquidator and other orders.

- (b) any further proceedings as may be issued against GSF in respect of which no insurance cover exists which would fund the First Plaintiffs' remuneration, costs and expenses in taking steps in the said proceeding, save for opposing any applications for leave to proceed pursuant to section 500(2) of the Act as they may elect to oppose.

4. Such further or other order as the Court thinks fit.

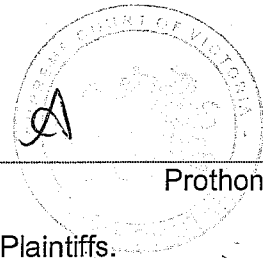

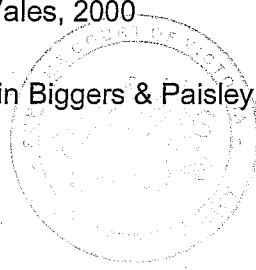
