CIRCULAR TO CREDITORS

I refer to the appointment of Martin Jones, Darren Weaver, James Stewart and I as Joint and Several Deed Administrators of GSTH on 16 February 2010 and our subsequent appointment as Joint and Several Trustees of the Trust on 31 January 2011.

As you are aware, at the previous creditors meeting held on 30 November 2010 creditors of GSTH resolved to approve the variation of to the Deed of Company Arrangement (DOCA) proposed by Mitsui Bussan Woodchip Oceania Pty Ltd (MWO).

I advise that on 31 January 2011, the Deed Administrators completed the transaction with MWO, which involved the Trust being created and resulted in the DOCA being wholly effectuated.

Based on these developments the Trustees intend to declare a dividend and distribute the proceeds to creditors in accordance with the statutory timeframe. In this regard, please find enclosed a Form 548 Notice of Intention to Declare Dividend, Form 534 Notice Inviting Formal Proof of Debt or Claim and a Form 535 Formal Proof of Debt for your completion and return to this office.

Pursuant to Corporations Regulation 5.6.65(2) of the Corporations Act 2001, creditors are required to submit a Form 535 Formal Proof of Debt form to this office within 21 days of notice (or prior to **1 March 2011**) otherwise they will be excluded from the dividend.
