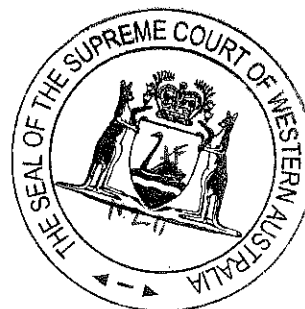

PLEADINGS

1. The time for compliance with order 1 of the orders of Le Miere J dated 15 December 2010 (**15 December orders**) and order 4 of the 15 December orders, insofar as it applies to the Represented Growers be extended to 4 March 2011.
2. The time for compliance with order 4 of the 15 December orders, insofar as it applies to the 4065th Fourth Defendant (**Bank**) be extended to 4 March 2011.

3. Nothing in the foregoing precludes any party from exercising his right to seek the re-listing of the matter for further directions at any time.

NEXT DIRECTIONS HEARING

4. The next directions hearing shall be at 9.15am on Tuesday, 8 March 2011.

5. The Represented Growers do pay the Plaintiffs' costs of and incidental to this directions hearing to be taxed if not agreed.
6. Paragraph 5 of the 15 December orders be varied by extending the time for the Plaintiffs to file and serve any reply and defence to the counterclaim to 21 March 2011.
