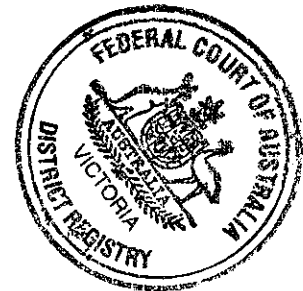

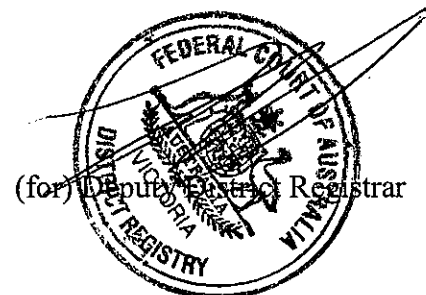
THE COURT ORDERS THAT:

1. Pursuant to Rule 1.1 of the Federal Court (Corporations) Rules 2000 the time for service of the originating process be abridged.
2. Subject to further order, pursuant to s 439A(6) of the *Corporations Act 2001* (Cth) ("the Act") the convening period for the meeting pursuant to s 439A(1) of the Act of creditors of each of:
  - (a) Clive Peeters Ltd (administrators appointed) (receivers and managers appointed) (ACN 058 868 018);
  - (b) Rick Hart Holdings Pty Ltd (administrators appointed) (receivers and managers appointed) (ACN 112 058 787);
  - (c) Hi-Fi Corporation (WA) Pty Ltd (administrators appointed) (receivers and managers appointed) (ACN 092 691 846);
  - (d) NTFQ Pty Ltd (administrators appointed) (receivers and managers appointed) (ACN 109 689 769);
  - (e) Clive Peeters Kitchens & Bathrooms Pty Ltd (administrators appointed) (receivers and managers appointed) (ACN 097 301 445);

- (f) Clive Peeters Wholesale Pty Ltd (administrators appointed) (receivers and managers appointed) (ACN 058 868 723),
- (together, "Trading Companies") be extended from 15 June 2010 to 12 October 2010.
3. Subject to further order, pursuant to s 439A(6) of the Act the convening period for the meeting pursuant to s 439A(1) of the Act of creditors of each of:
- (a) Watercell Pty Ltd (administrators appointed) (receivers and managers appointed) (ACN 093 965 998)
- (b) Clive Peeters Home Entertainment (Brisbane) Pty Ltd (administrators appointed) (receivers and managers appointed) (ACN 097 301 490),
- (together, "Dormant Companies") be extended from 15 June 2010 to 13 July 2010.
4. Pursuant to s 447A(1) of the Act, Pt 5.3A of the Act is to operate in relation to the Trading Companies and the Dormant Companies as if it provided in s 439A(2) of the Act that the administrators may also hold the meetings of creditors of the Trading Companies and the Dormant Companies pursuant to s 439A(1) of the Act at any time before, or within five business days after, the end of the convening period as extended by order 2 and 3 above, as the case may be, provided that the plaintiffs give notice of the meetings in accordance with s 439A(3) of the Act at least five business days before each such meeting.
5. Liberty is granted to the creditors of the Trading companies and the Dormant Companies to apply to the Court on two days written notice to the plaintiffs.
6. The administrators' costs of this application be costs in the administration of the Trading Companies and the Dormant Companies.
7. Pursuant to s 447D of the Act the first plaintiffs are to give notice of these orders by publishing a copy on their website, [www.ferrierhodgson.com.au](http://www.ferrierhodgson.com.au) within two business days of these orders being made.
