Notice inviting responses from Investors

Investors will shortly be receiving an important notice which has been approved by the Federal Court of Australia and the High Court of New Zealand (**Notice**). The Notice outlines the next steps in the Court applications in both Australia and New Zealand. The Notice will invite investors to return questionnaires to the Liquidators outlining their views by **4pm NZDT / 2pm AEDT on 6 December 2019**. These responses will then be reviewed by the Liquidators and provided to the Courts at the appropriate time.

The Liquidators encourage all Investors to read the notice carefully.

Investor participation in this process is optional. The Liquidators will be guided by the Courts in determining how to return investor funds, and all investors will have their funds returned to them in the manner directed by the Court regardless of whether they participate in the Court process.

Information sessions

To assist Investors, we intend to hold a series of optional information sessions to provide further information on the investigations to date, the Court process and the next steps.
